On October 27, 1995 a confidential source telephonically contacted SA

The source related that "Dateline", an NBC television show, had been contacted by an unknown attorney representing a Los Angeles Agent of the Federal Bureau of Investigation (FBI). On behalf of the agent, the attorney offered to sell a copy of the surveillance tape recovered from Oklahoma City which shows the activity outside of the Alfred P. Murrah Federal building just prior to the bomb blast.

It was represented that the video tape would contain time-lapse photography of the arrival and then departure of a UPS truck. Then a Ryder truck pulls up and a male resembling Timothy McVey is seen exiting the driver's side of the Ryder truck and then walking away. Next, a second male is seen exiting the passenger side of the Ryder truck and walking to the back of the truck. The second male then walks away in the same direction as the first male.

The source related that the attorney is asking for over one million dollars for the tape. As proof of his access to the tape, the attorney turned over to NBC what appeared to be the 6 page search log from the April 22, 1995 FBI search of 109 South 2nd Street, Harrington, Kansas, bearing file number 174A-OC-52160(sic). The log includes a list of firearms seized and

includes the names of recording and searching agents and their initials.

The source read the names aloud, and none were the names of current Los Angeles FBI employees.

The source further related that another member of the news media is aware of this transaction and is preparing a second news article based on this information about the transaction. The second article will include that Los Angeles Special Agent in Charge Charlie J. Parsons was notified by the FBI Office of Professional Responsibility, of this transaction. The second news article may include that the FBI agent providing this information is a GS-13, 16 year government veteran, age 38-42, and a former sniper instructor at the Carlos Haichcoch School.

The second member of the news media is also claiming that an unnamed Los Angeles Supervisor has previously leaked stories to the "Los Angeles Times", including information regarding telephone logs possibly involving an illegal wiretap.

On October 30, 1995 a confidential source, telephonically contacted SA

The source related that negotiations continue between an unknown Los Angeles Agent of the Federal Bureau of Investigation (FBI) and "Dateline", an NBC television show, for the purchase of a video tape depicting the arrival of the Ryder truck at the Alfred P. Murrah Federal Building in Oklahoma City. The current offer by Dateline is \$880,000.00, to be paid in a manner so as not to create a paper trail.

In addition, the tape has also been offered to CBS. Reportedly, CBS has agreed to negotiate for the tape on two conditions: that McVey is clear on the tape, and that the second person also be clear on the tape.

The agent continues to be advised by an attorney located in Oklahoma City. According to the source, the attorney counseled the agent to resign from the FBI.

The agent is being represented at negotiations by Robert Jerlow, Jerlow and Associates, a private investigator licensed in the State of Oklahoma, address 6957 NW Expressway, #184, Oklahoma City, Oklahoma, home telephone (405)721-0085, work telephone (405)721-2336, pager 1-800-SKYPAGE(819-6157).

It is believed that Jerlow is holding out for one million dollars and may have indicated that they will market the tape to CNN next.

Dateline was able to view the video tape at the home of an Orange County Deputy Sheriff. The source related that Jerlow's wife, Colette has some ties to Orange County.

The source further related that Jerlow and the agent served together in the U.S. Marine Corps from 1982 to 1988 and were in Beirut, Lebanon together.

The source also related that the unknown agent is a currently working with the U.S. Secret Service on some matter.

In the past, Jerlow has provided the agent's supervisor with various telephone printouts, including printouts from Terry

and James Nichols. Jerlow is also said to offer "hacker" services.

The source believes that members of the media may be very close to printing a story about these negotiations.
