Who Are These Domestic Enemies?

I've always been impressed with the wisdom and common sense of those men who gave us the Declaration of Independence and our Constitution. They knew from experience how King George III violated the Magna Carta. All Representatives, Senators, Judges and all public servants are required to take the same oath to defend the Constitution from all enemies, foreign and domestic, that I took back in 1951.

Those great Americans back in 1787 set a trap that needs to be used in 2015 against our “domestic enemies.”

Any public servant who defends the government—if there is a controversy between We the PEOPLE and our government—is a Domestic Enemy. I have not found anything in the Constitution granting any power, to any public servant, to defend government. If the IRS picks a fight with me, I can keep any federal judge from being a problem by reminding him of his conflict of interest.

You see, the judge is a beneficiary of the tax laws. That defense has been used even in traffic court cases. Public servant's wages are paid from our tax money. Now, We the People can demand a judge defend the Constitution in any court proceeding. I am convinced no judge will want to be identified as a domestic enemy!

These “Domestic Enemies” Have a Conflict of Interest . . .

Any public servant wanting to tangle with me now will be identified as a Domestic Enemy with a conflict of interest. We have had major wins going back several years using the conflict of interest truth and now we are about to identify some domestic enemies. People trying to make the Common Law effective should use 7th Amendment common law Juries in conjunction with the conflict of interest and the domestic enemy truths. I think they will win some battles. I have helped people with tax court problems with good results using the conflict of interest truth.

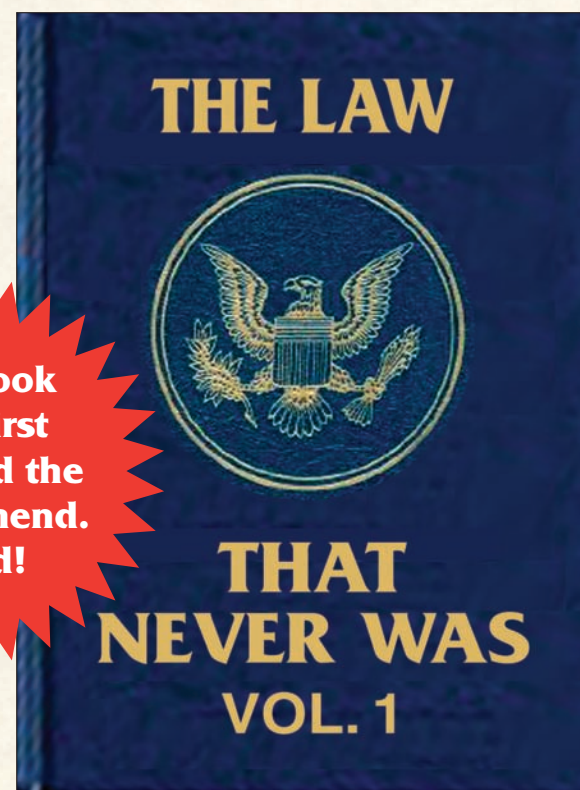
Judges Sent Scrambling . . .
